FIRST SUPPLEMENTARY PROSPECTUS DATED 12 MARCH 2025

A copy of this First Supplementary Prospectus has been lodged with the Monetary Authority of Singapore who assumes no responsibility for its contents.

This First Supplementary Prospectus is lodged pursuant to Section 298 of the Securities and Futures Act 2001 and is supplemental to the prospectus registered by the Authority on 13 January 2025 (the “**Prospectus**”) relating to the Nikko AM Asia Limited VCC (the “**Company**”).

Terms used in this First Supplementary Prospectus will have the meaning and construction ascribed to them in the Prospectus and references to “**paragraph**” are to the paragraphs of the Prospectus. This First Supplementary Prospectus is to be read and construed in conjunction and as one document with the Prospectus.

This First Supplementary Prospectus sets out the amendments made to the Prospectus to reflect a change of key executives of Nikko Asset Management Asia Limited (the “**Manager**”) in relation to (i) the NikkoAM-StraitsTrading MSCI China Electric Vehicles and Future Mobility ETF; and (ii) the Amova MSCI AC Asia ex Japan ex China Index ETF, the sub-funds within the Company (the “**Sub-Funds**”) with effect from 12 March 2025 (the “**Effective Date**”).

In this connection, the Prospectus will be amended as follows:-

(a) Paragraph 10 of the Prospectus

Mr Mohammed Zaidi will cease to be a key executive of the Manager from the Effective Date.

Accordingly, the first paragraph of paragraph 10 of the Prospectus is hereby deleted in its entirety and replaced with the following:-

“10. The other key executives of the Manager in relation to the Sub-Funds are Lai Yeu Huan and Peter Monson (whose descriptions are set out below).”.

(b) Paragraph 10(i) of the Prospectus

Mr Mohammed Zaidi will cease to be a key executive of the Manager in relation to the NikkoAM-StraitsTrading MSCI China Electric Vehicles and Future Mobility ETF from the Effective Date.

Accordingly, the section relating to “Mohammed Zaidi” under paragraph 10(i) of the Prospectus is hereby deleted in its entirety.

(c) Paragraph 10(ii) of the Prospectus

Mr Peter Monson will be appointed as a key executive of the Manager in relation to the Amova MSCI AC Asia ex Japan ex China Index ETF from the Effective Date.

Accordingly, the sentence under paragraph 10(ii) of the Prospectus is hereby deleted in its entirety and replaced with the following:-

“Lai Yeu Huan and Peter Monson (whose descriptions are set out above).”.
